Awareness


- Most effective campaigns had on-going promotion of high visibility enforcement efforts.
- Important to have videos and photos to share with community and elected officials to promote efforts.

Integrated Programming

- Location has recent roadway or sidewalk safety project.
- Location will have improvements within 18 months.
- Education efforts wrapping around enforcement efforts to expend presence in the area.

Creating a Comprehensive Campaign

It takes time, but it's worth the effort.

- Outline priorities for outreach and enforcement in your local strategic highway safety plan.
 - Montgomery County moved to "Focus on the Five" as part of new Vision Zero 2030 Plan
 - Data analysis for the new plan highlights the who, what, when, and where involved in high crashrisks. This helps to identify the potential countermeasures that may be needed for each area.
- Plan out work at least a quarter out.
 - Utilize NHTSA and State campaign calendars to make syncing efforts seamless.
 - Develop your HVE wave dates, times, and locations with your engineering and education partners.
 - Determine what resources (officers, outreach staff, outreach contractors) can be dedicated.
 - Engaging non-government organizations such as WRAP.
- During the campaign.
 - Utilize all outreach channels available (press releases, media invitations, social media) to let the public know about your efforts.
 - Take video and photos to show your current efforts and to include in updates to community groups and elected officials.
- After the campaign.
 - Informal debriefs to discuss what worked and what may need to change for the next wave.

Goals of the Centralized Traffic Unit

Purposeful Policing to Save Lives



Perform proactive, high visibility enforcement against dangerous driving behaviors.



Utilize data and leading practices to make the most of our resources.



Collaborate with county government and community partners to end traffic fatalities.

Moving to a Centralized Model

District Model

- Each district had at least:
 - 1 sergeant and 1 corporal
 - 4-7 traffic complaint officers.
- Each district used data provided by Headquarters.
- Each district prioritized efforts based on data and incoming complaints.

Central Model

- Central Unit has:
 - 2 shifts day and evening
 - o 2 sergeants, 2 corporals
 - o 24 police officers.
- Each district has at least 1 traffic complaint officer.
- Team works across the County with focused efforts across all six districts.
- Incoming complaints handled by districts.


